AN ORDINANCE
ANNEXING CERTAIN TERRITORY
TO THE CITY OF URBANA

(Sunnycrest Apartments II / 1702 E. Colorado Avenue)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Philo Fire Protection District and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on <u>February 6</u>, 1997, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, <u>February 17</u>, 1997, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the <u>13th</u> day of <u>February</u>, 1997; and

WHEREAS, this Ordinance was not voted upon at said Council meeting held at 7:30 p.m., Monday, February 17, 1997, and therefore was rescheduled to a special meeting of this Council; and

WHEREAS, notice of the special meeting of this Council was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, that this Ordinance would be voted upon at a special meeting of this Council at 7:30 p.m., Monday, February 24, 1997; and

WHEREAS, a written petition signed by all of the owners of Record, of all land within such territory, has been filed with the City Clerk of the City of Urbana, Illinois, requesting annexation thereof to the City of Urbana; and

WHEREAS, there are no electors residing on the premises; and

WHEREAS, the City Council passed Ordinance No. 9697-31 on August 19, 1996 approving and authorizing the execution of an annexation agreement wherein the Corporate Authorities agreed to expeditiously annex said territory; and

WHEREAS, the territory to be annexed by this Ordinance is presently located within Champaign County's R-4 Multiple Family Residence zoning district and upon annexation will be automatically classified R-4 Medium Density Multiple Family Residential in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

All of Lot 1 of Sunnycrest Apartments II Subdivision, Champaign County, Illinois, per plat recorded in Plat Book CC, at page 233, in the Office of the Recorder, Champaign County, Illinois, containing 9.70 acres, more or less.

Together with the following described adjacent public Right-of-Way which is by operation of the law, automatically annexed with the adoption of an Annexation Ordinance pertaining to this parcel:

All of Colorado Avenue, being 33.00 feet in width, adjacent to said Lot 1, containing 0.24 acre, more or less.

All situated in Champaign County, Illinois.

commonly known for reference as <u>1702 E. Colorado Avenue</u>, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcel, prior to annexation, has the parcel index number <u>30-21-21-200-011</u>, and following annexation the said parcel should bear the parcel index number <u>93-21-21-200-011</u>.

Section 2. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the County Clerk and the County Election Authority of Champaign County, Illinois.

Section 3. The Zoning Ordinance of the City of Urbana, Illinois, and the Zoning Map of Urbana, Illinois, are hereby amended to classify the real property herein annexed as R-4 Medium

Density Multiple Family Residential in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance.

Section 4. This Ordinance shall be in full force and effect from after its passage and recording as provided by law.
