ORDINANCE NO. <u>9798-32</u>

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 8-3 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS (BRIARCLIFF, KENYON); AND AMENDING SCHEDULE L OF SECTION 14-7(B) REQUIRING CURBS TO BE PAINTED YELLOW (CEDAR)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection:

Briarcliff Dr.	Eastbound at	Jackson Rd.
Kenyon Rd.	Northbound at	Killarney St.

<u>Section 2.</u> That Schedule L of Section 14-7(B), entitled "Curb Painted Yellow by Order of City Council Pursuant to Section 14-7", of Article XIV of the Urbana Local Traffic Code, is hereby amended by adding to that schedule the following areas where the curb shall be painted yellow:

<u>Section 3.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>Section 4.</u> This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.
