AN ORDINANCE  
ABATING TAX LEVY FOR \$1.0 MILLION  
GENERAL OBLIGATION BONDS, SERIES 1992

WHEREAS, the Urbana City Council did, on the 21st day of September, 1992, pass a certain ordinance, to-wit: Ordinance No. 9293-24, entitled:

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$1,000,000 GENERAL OBLIGATION BONDS, SERIES 1992, OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, FOR THE LEVY OF A DIRECT ANNUAL TAX SUFFICIENT TO PAY THE PRINCIPAL AND INTEREST ON SUCH SERIES 1992 BONDS,

which ordinance was duly filed with the County Clerk of the County of Champaign, Illinois, on September 28, 1992; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. Abatement. That the tax levy provided in Section 11 of the Bond Ordinance (Ordinance No. 9293-24, filed September 28, 1992, with the County Clerk of The County of Champaign, Illinois) be abated for the 1997 tax levy year (to be received in 1998), as follows:

1997	\$ 0 [instead of \$128,875.00]	\$128,875.00

Section 2. Filing. As soon as this ordinance becomes effective, a copy hereof certified by the City Clerk, which certificate shall recite that this ordinance has been duly adopted, shall be filed with the County Clerk of Champaign County, Illinois, who is hereby directed to abate taxes as set forth above in Section 1 and to ascertain the rate per cent required to produce the aggregated tax hereinabove provided to be levied in 1995, as shown above to be levied, and to extend the same for collection on the tax books in connection with other taxes levied in such year, in and by the City for general corporate purposes of the City, and in such year levied and collected in like manner as taxes for general corporate purposes for such year is levied and collected and, when collected, such taxes shall be used solely for the purpose of paying the principal and interest on the Bonds

herein described as the same become due and payable. The tax levy shall be abated as parenthetically shown above in Section 1. Otherwise, Ordinance No. 9293-24 shall be given effect according to its terms.

Section 3. Effective Date. This ordinance shall become effective immediately upon its passage and approval. Except as provided in this ordinance, the Bond Ordinance shall continue in effect according to the express terms thereof.

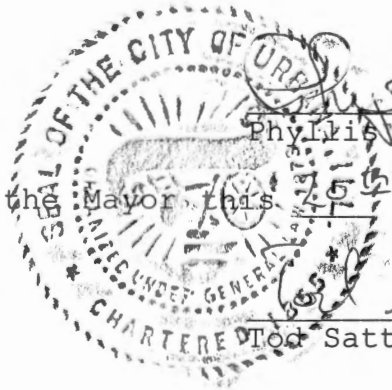
