ORDINANCE NO. 9798-129

AN ORDINANCE AMENDING ORDINANCE NO. 9798-76 (PARKED WITH EXPIRED REGISTRATION PLATES) AND ENACTING SAID ORDINANCE AS SECTION 23-266 OF THE URBANA LOCAL TRAFFIC CODE

WHEREAS, Ordinance No. 9798-76 was passed by the City Council on the 15th day of December, 1997; and

WHEREAS, the Parking Enforcement Division of the Urbana Police Department has suggested certain amendments thereto which would enhance the desired effect of the said Ordinance.

NOW THEREFORE, BE IT ORDAINED that Section 1 and Section 2 of Ordinance No. 9798-76 are amended to read as follows and such shall be enacted as Section 23-266 of the Urbana Local Traffic Code:

"Sec. 23-266. Expired Registration Plates/No Registration Plates.

<u>Section 1.</u> Any motor vehicle which would be required to have motor vehicle registration plates under the laws of the State of Illinois to be operated upon the public highways, must display registration plates issued by the State of Illinois or another state which are valid and unexpired at all times when such vehicle is on a public street in the City of Urbana, or in a parking lot owned by the City of Urbana.

<u>Section 2.</u> That a vehicle found upon a public street in the City of Urbana, or in a parking lot owned by the City of Urbana, in violation of this Ordinance shall subject the owner thereof to a fine of not less than Twenty-Five Dollars (\$25.00) or each day that such vehicle remains in violation of this Ordinance."

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
