ORDINANCE NO. 9798-131

AN AMENDMENT TO A PART OF THE ZONING ORDINANCE AND ZONING MAP OF THE CITY OF URBANA, ILLINOIS

(3, 4, 5, 6 Florida Court and 101 and 103 West Florida Avenue, Plan Case No. 1695-M-98)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on June 4, 1998 concerning the petition filed by Rudolf and Armine Mortimer, the owners of 3 Florida Court; Cloydia and Richard Larimore, the owners of 4 Florida Court; Glenn E. and R. Weldon Larimore, the owners of 5 Florida Court; Amy and Jon Outland, the owners of 101 W. Florida Avenue; and the City of Urbana, under the directive of the Urbana City Council, on behalf of 103 W. Florida Court in Plan Case #1695-M-98; and

WHEREAS, said requested rezoning is consistent with the City of Urbana's Official Comprehensive Plan Map and with the goals and objectives of the Comprehensive Plan; and

WHEREAS, the Urbana Plan Commission voted 5-1 to forward the case to the Urbana City Council with a recommendation to approve the rezoning request of the properties herein described below and commonly known as 3, 4, 5, 6 Florida Court and 101 and 103 West Florida Avenue from R-2 Single Family Residential to R-1 Single Family Residential; and

WHEREAS, the findings of the Plan Commission indicate that approval of the rezoning request would promote the general health, safety, morals, and general welfare of the public; and

NOW, THEREAFTER, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The Zoning Ordinance and Zoning Map of the City of Urbana, Illinois, are herewith and hereby amended to change the zoning classification of the following described area so that the properties commonly known as 3, 4, 5, 6 Florida Court and 101 and 103 West Florida Avenue from R-2 Single Family Residential to R-1 Single Family Residential:

LEGAL DESCRIPTION: The North 100 feet of the South 200 feet of the West 1 Acre of the East 2 acres of the North half of the NW ¼ of the NE ¼ of Section 20 Township 19 North, Range 9 East of the Third Principal Meridian, in Champaign County, Illinois.

A non-exclusive easement for the benefit of Parcel 1 as created by Warranty deed from Clara L. Mahn to Thomas Raymond Webber and Ruth Webber dated April 1, 1946 and recorded April 1, 1946 in Book 270 at page 313 as document 398642 for driveway and walking purposes over: the West 10 feet of even width of the East acre of the N1/2 of the NW ¼ of the NW ¼ of the NW ¼ aforesaid except the South 85 feet thereof; and also over the East 10 feet of the North 15 feet of the South 100 feet of the West acre of the East 2 acres of the N ½ of the NW ¼ of the NW ¼ of the NW ¼ aforesaid, and also the East 10 feet of the West one

acre of the east 2 acres (except the south 200 feet thereof), as reserved in warranty deed dated February 7, 1951 and recorded February 27, 1951 in Book 433 Page 148 as Document no. 473703 from Thomas Raymond Webber and Ruth W. Webber to Earnest H. Shideler and Bertha Lee Shideler, of the North ½ of Northwest quarter of the northwest quarter of the northwest quarter of foresaid.
