## ORDINANCE NO. 9798-81

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 8-3 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS (ORCHARD, PARK, STONE CREEK, MUIRFIELD PLACE, MYRA RIDGE DR., AMBER LANE)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection:

Stone Creek Boulevard	Southbound	Windsor Rd.
Stone Creek Boulevard	Eastbound	High Cross Rd.
Muirfield Place	Eastbound	Stone Creek Blvd.
Muirfield Place	Northbound	Stone Creek Blvd.
Myra Ridge Dr.	Southbound	Windsor Rd
Amber Lane	Westbound	Philo Rd

Section 2. That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following intersections, shown in strikethrough text, where motorists will no longer be required to stop:

Orchard	Northbound	Park
Park	Eastbound	Orchard
Park	Westbound	Orchard

<u>Section 3.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>Section 4.</u> This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect

from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
