ORDINANCE NO. 9798-82

AN ORDINANCE AMENDING SECTION 5-2 OF THE URBANA LOCAL TRAFFIC ORDINANCE, AS AMENDED, ESTABLISHING SPEED REGULATIONS ON A CERTAIN PORTION OF WINDSOR ROAD (SUSAN STONE)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule I of Section 5-2 of Article V, entitled "Speed Regulations", of the Urbana Local Traffic Ordinance, as amended, is hereby further amended by adding to that schedule the following speed regulations for a certain portion of Windsor Road:

From the western edge of the High Cross Road right of way to 570' east of the eastern edge of the Susan Stone Drive right of way the speed limit shall be forty-five miles per hour (45 MPH).

Section 2. That the Traffic Engineer is hereby authorized and directed to post the appropriate signs indicating the speed regulations set forth in this Ordinance.

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.
