## ORDINANCE NO. 9798-98

## AN ORDINANCE CHANGING A STREET NAME

(Cunningham Avenue)

WHEREAS, pursuant to Section 65 of the Illinois Compiled Statutes, Act 5/11-80-19, the corporate authorities of each municipality may name originally and then may change the name of any street, avenue, alley, or other public place, such change to be effective as therein further provided and conditioned; and

WHEREAS, due to roadway improvements and the changing of alignment of University Avenue, the streets between Vine and Broadway which lie immediately south of University Avenue, commonly known as Cunningham Avenue and Courtesy Road, present a confusing array for addressing purposes; and

WHEREAS, the portion of Cunningham Avenue right-of-way described below does not align with the remainder of Cunningham Avenue and can not be extended from its present southern or northern termini and no current buildings or properties are addressed along this section of right-of-way, but the said portion of Cunningham Avenue right-of-way does somewhat align with and run into Courtesy Road (even though a part of Courtesy Road was closed by Ordinance No. 6869-027, (amended by Ordinance No. 7273-033); and

WHEREAS, there is a desire to avoid confusion in locating an existing business bearing the address of 201 East Courtesy Road, and it is deemed in the best interests of the City of Urbana to make the following street name change.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

<u>Section 1.</u> That the following described public right-of-way is hereby changed from "Cunningham Avenue" to "Courtesy Road".

A road in the Southwest Quarter of the Southeast Quarter of Section 8, Township 19 North, Range 9 East of the Third Principal Meridian, further described as follows:


All that part of Cunningham Avenue (formerly, Heater Road, Brownfield Road, Chicago and Shelbyville Road) lying East of Broadway Avenue and south of University Avenue.

Situated in the City of Urbana, Champaign County, Illinois, as shown on the sketch attached hereto and made a part hereof.

<u>Section 2.</u> That certified copies of this Ordinance be delivered to the Champaign County Clerk, the United States Postal Service branch office serving the area, and the District Engineer of the Illinois Department of Transportation in Paris, Illinois, by certified or registered mail.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.




## LEGEND R-O-W LINE PROPERTY LINE RAILROAD CENTERLINE
