

ORDINANCE NO. 1999-02-008

AN ORDINANCE AMENDING SECTION 23-292(c) OF THE URBANA LOCAL
TRAFFIC CODE, REGARDING PAYMENT OF TOWING "CALL FEE"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
URBANA, ILLINOIS, as follows:

Section 1. That Section 23-292(c), entitled "Owner at Scene" of the Urbana Local Traffic Code as amended, is hereby amended to read as follows, with the underlined language indicating new language:

Sec. 23-292(c) Owner at Scene. No relocater shall remove a vehicle when the owner or operator of such vehicle is present or arrives at the vehicle location at any time prior to the completion of removal, and is willing and able to remove the vehicle immediately and makes prompt payment of the following "call fee" to the relocater prior to release of the vehicle to the owner or operator. The relocater shall be permitted to charge the owner or operator with a "call fee" to cover the relocater's expenses in responding to the request to remove the unauthorized vehicle. Such "call fee" shall not exceed one-half (1/2) of the reasonable towing charge for removing said vehicle. The relocater may not require payment of the "call fee" unless the call fee is payable by major credit card at the scene in addition to being payable in cash.

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

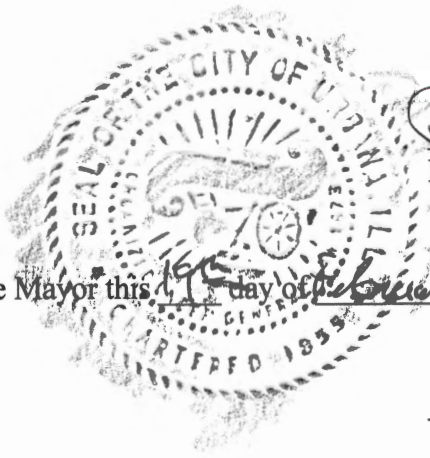
