## **ORDINANCE NO.** <u>1999–06</u>–047

## <u>AN AMENDMENT</u> TO A PART OF THE ZONING MAP OF THE CITY OF URBANA, ILLINOIS

## (506 E. Anthony, Plan Case No. 1720-M-99)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on May 20, 1999 concerning the petition filed by James Q. Hurlbert regarding 506 E. Anthony in Plan Case #1720-M-99; and

WHEREAS, said requested rezoning is consistent with the City of Urbana's Official Comprehensive Plan Map and with the goals and objectives of the Comprehensive Plan; and

WHEREAS, the Urbana Plan Commission voted 5 ayes and 1 abstention to forward the case to the Urbana City Council with a recommendation to approve the rezoning request of the property herein described below and commonly known as 506 E. Anthony from IN, Industrial to B-3, General Business.

WHEREAS, the findings of the Plan Commission indicate that approval of the rezoning request would promote the general health, safety, morals, and general welfare of the public; and

NOW, THEREAFTER, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF URBANA, ILLINOIS, THAT:

<u>Section 1.</u> The Zoning Ordinance and Zoning Map of the City of Urbana, Illinois, are herewith and hereby amended to change the zoning classification of the following described area so that the property commonly known as 506 E. Anthony from IN, Industrial to B-3, General Business:

LEGAL DESCRIPTION: Lot 3 of Harry Gill 2<sup>nd</sup> Subdivision

PERMANENT PARCELS #: 91-21-05-277-003

LOCATED AT: 506 E. Anthony, Urbana, Illinois.

The said area above described being represented on the map attached hereto and incorporated herein by reference.

<u>Section 2.</u> The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities. This Ordinance shall be in full force and effect from and after its passage and publication in accordance with the terms of Chapter 65, Section 1-2-4 of the Illinois Compiled Statutes (65 ILCS 5/1-2-4).

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a super-majority of the Members of the City Council of the City of Urbana, Illinois, at a special meeting of said Council.
