WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on \_\_June 8th\_\_\_\_, 1999, that this Ordinance would be voted upon at a meeting of this Council at 7:30 p.m., Monday, June 21, 1999, and the Affidavit of mailing such Notice was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the \_9th\_\_ day of \_June\_\_\_, 1999; and

WHEREAS, there are no electors residing within said territory; and

WHEREAS, the City Council passed Ordinance No. 1999-05-035 on May 17, 1999 approving and authorizing the execution of an annexation agreement wherein the property owner agreed to annex the hereinafter described territory to the City of Urbana within thirty days from the effective date of said annexation agreement; and

WHEREAS, the territory to be annexed by this Ordinance is presently located within Champaign County's B-4 General Business and R-3 Two-Family Residencezoning districts and upon annexation will automatically be classified B-3 General Business and R-3 Single and Two-Family Residential upon annexation in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 5. The territory annexed herein is assigned to City of Urbana Ward 5.

Section 6. This Ordinance shall take effect at 12:00 a.m. CDT, June 29, 1999.
