ORDINANCE NO. 1999-06-060

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 8-3 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS (Rainbow View Court at Rainbow View Drive, Myra Ridge Drive at Amber Lane and Amber Lane at Stone Creek Boulevard)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 8-3, entitled "Stop Signs Pursuant to Section 8-3", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersections where drivers of vehicles shall be required to stop before entering the intersection:

Rainbow View Court	Southbound	Rainbow View Drive
Myra Ridge Drive	Northbound	Amber Lane
Amber Lane	Eastbound	Stone Creek Boulevard

<u>Section 2.</u> All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>Section 3.</u> This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
