

ORDINANCE NO. 1999-07-075

AN ORDINANCE REGARDING UNAUTHORIZED PARKING IN RENTAL SPACES

BE IT ORDAINED BY THE URBANA CITY that:

Section 1. The Urbana City Code is hereby amended to add the following section:

“Sec. 23-248. Unauthorized Use of Rental Spaces.

- (a) It shall be unlawful for any person to cause a motor vehicle to be parked in a reserved rental space during the hours such space is posted as rental, without displaying the permit which entitles such vehicle to occupy such rental space;
- (b) In the City parking facility located in the block bounded by Elm Street, Race Street, Main Street, and Broadway Avenue, between the hours of 7:00 a.m. and 6:00 p.m. on any day except Saturday, Sunday or any City holiday, it shall be unlawful to cause a motor vehicle to be parked:
 - (1) in a reserved rental space without displaying the permit which entitles such vehicle to occupy such rental space; and
 - (2) on the ground floor if such vehicle has a current “Deck, Unreserved Permit”).
- (c) Anyone violating this section shall be fined Fifteen (\$15.00) Dollars if paid within seventy-two (72) hours and Twenty (\$20.00) Dollars if not paid within seventy-two (72) hours of the date of issuance of the notice of violation.”

Section 2. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.





