

ORDINANCE NO. 1999-07-077

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

(Illinois Street, Michigan Avenue, Mathews Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited at All Times on Certain Streets", of the Urbana Local Traffic Code, is hereby amended by DELETING the following language under the heading, **"No Parking This Side of Street"** as follows:

<u>Street</u>	<u>Direction</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Mathews	Southbound	Ellis	Church	West

Section 2. That Schedule J of Section 23-183, entitled "Parking Prohibited at All Times on Certain Streets", of the Urbana Local Traffic Code, is hereby amended by ADDING the following language under the heading, **"No Parking This Side of Street"** as follows:

<u>Street</u>	<u>Direction</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Mathews	Southbound	Ellis	Beech	West
Mathews	Southbound	Dublin	Church	West
Illinois	Westbound	The centerline of Poplar to 65 feet west of the centerline of Poplar		North
Illinois	Eastbound	The centerline of Poplar to 65 feet west of the centerline of Poplar		South
Michigan	Westbound	The centerline of Vine to 275 feet east of the centerline of Vine		North

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.


