ORDINANCE NO. 1999-07-078

AN ORDINANCE AMENDING SCHEDULE L OF SECTION 23-187(b) OF THE URBANA LOCAL TRAFFIC CODE DESIGNATING YELLOW CURBS (Washington Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule L of Section 23-187(b), entitled "Parking Prohibited in Specified Places", of the Urbana Local Traffic Code, is hereby amended by adding the following language, under the heading, "Curb Painted Yellow" as follows:

Street	From	To	Side	of Street
Washington	The centerline of Maple to 100' West of the centerline of Maple			South
Washington	The centerline 90' East of the of Maple			South

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

 $\frac{\text{Section 4.}}{\text{in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.}$
