

ORDINANCE NO. 1999-08-082—

AN ORDINANCE APPROVING
AN URBANA HOME CONSORTIUM **RECIPIENT** AGREEMENT
(Habitat For Humanity of Champaign County-East Water Street Improvements)

WHEREAS, the City of Urbana, the City of Champaign, and Champaign County have been jointly designated as a Participating Jurisdiction by the U.S. Department of Housing and Urban Development (hereinafter "HUD") for purposes of receiving HOME Investment Partnerships (hereinafter "HOME") Program funds in the name of the Urbana HOME Consortium under provisions of Title II of the Cranston-Gonzales National Affordable Housing Act of 1990, as amended (42 U.S.C. 12701 *et seq.*); and

WHEREAS, the Urbana HOME Consortium has received HOME Program funds from HUD for the period beginning July 1, 1999 and ending June 30, 2000, to increase affordable housing opportunities for low-income residents of Urbana, Champaign, and unincorporated Champaign County; and

WHEREAS, the Urbana City Council has adopted a Consolidated Plan for Program Years 1995-1999 (hereinafter the "Consolidated Plan") which budgets \$931,000 in Urbana HOME Consortium funds for the period beginning July 1, 1999 and ending June 30, 2000, including \$254,075 set aside for use by the City of Urbana in accordance with an Intergovernmental Agreement Concerning Administration of a Champaign/Urbana/Champaign County HOME Investment partnerships Consortium fully executed on June 25, 1999 (hereinafter the "Intergovernmental Agreement"); and

WHEREAS, the Consolidated Plan promotes expansion of homeownership opportunities and recommends that the City expand home construction opportunities for low-income households; and

WHEREAS, Habitat for Humanity of Champaign County has applied to the City for FY1999-2000 Urbana HOME Consortium funds to improve infrastructure to support construction of single-family residences in Urbana, Illinois; and

WHEREAS, Habitat for Humanity of Champaign County has been designated as a recipient of HOME funds for the Consortium for FY1999-2000.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

1. That the City of Urbana hereby approves the *Urbana HOME Consortium Recipient Agreement (Habitat for Humanity of Champaign County-East Water Street Improvements)*, a copy of which is attached hereto and incorporated herein by reference, and authorizes the Mayor of the City of Urbana to execute the same on behalf of the Urbana HOME Consortium.

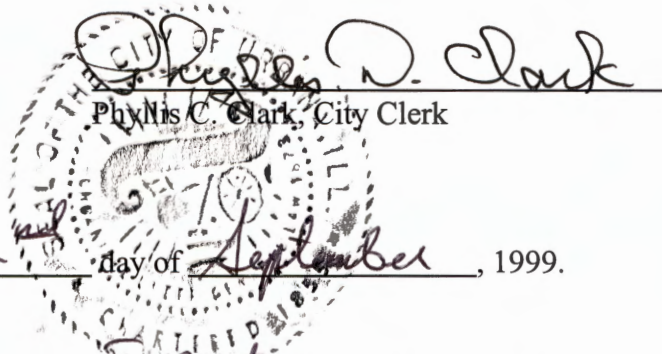
