

ORDINANCE NO. 1999-11-113

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION AND AMENDING SCHEDULE I OF SECTION 23-94 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING YIELD SIGNS AT A CERTAIN INTERSECTION  
(Washington Street at Lierman Avenue; Pennsylvania Avenue at Kinch Street; Gregory Street at Clark Street; Harvey Street at Clark Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

<u>Street</u>	<u>Direction</u>	<u>Street</u>
Washington Street	Eastbound	Lierman Avenue
Washington Street	Westbound	Lierman Avenue
Pennsylvania Avenue	Westbound	Kinch Street
Gregory Street	Northbound	Clark Street
Gregory Street	Southbound	Clark Street
Harvey Street	Northbound	Clark Street
Harvey Street	Southbound	Clark Street

Section 2. That Schedule I of Section 23-94, entitled "Yield Signs Pursuant to Section 23-94", of Article VIII of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following intersection where drivers of vehicles shall be required to yield before entering the intersection:

<u>Street</u>	<u>Direction</u>	<u>Street</u>
Gregory Street	Northbound	Clark Street
Gregory Street	Southbound	Clark Street
Harvey Street	Northbound	Clark Street
Harvey Street	Southbound	Clark Street

Section 3. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 4. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 5. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.


