

ORDINANCE NO. 2000-01-001

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT CERTAIN INTERSECTIONS
(Ridge Park Drive at Myra Ridge Drive; Silver Hill Drive at Myra Ridge Drive; Autumn Ridge Drive at Myra Ridge Drive; Myra Ridge Drive at Trails Drive; Chatham Drive at Trails Drive; Chatham Court at Trails Drive; Baronry Drive at Trails Drive; Fawn Hill Court at Trails Drive; Elm Street at Dodson Drive)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

Myra Ridge Drive	Southbound	Trails Drive
Chatham Court	Northbound	Trails Drive
Chatham Drive	Southbound	Trails Drive
Baronry Drive	Northbound	Trails Drive
Baronry Drive	Southbound	Trails Drive
Fawn Hill Court	Northbound	Trails Drive
Elm Street	Eastbound	Dodson Drive
Elm Street	Westbound	Dodson Drive

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.



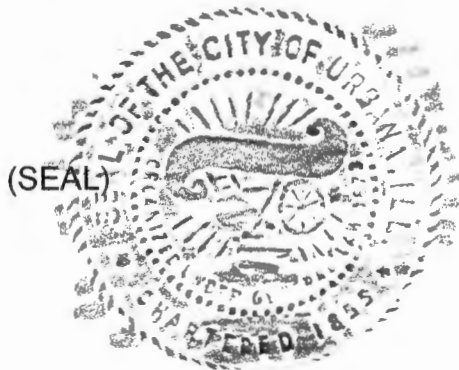
