ORDINANCE NO. 2000-03-034

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA

(1909 E. Airport Road / Landis Farm Subdivision)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and includes certain territory within the Urbana and Somer Townships, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on ______March_21____, 2000, that this Ordinance would be voted upon at a meeting of this Council at 7:30 p.m., Monday, April 3, 2000, and the Affidavit of mailing such Notice was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the ______29th_____ day of ______March_____, 2000; and

WHEREAS, there are no electors residing within said territory; and
WHEREAS, the City Council passed Ordinance No. 1999-09-0981 on October
4, 1999 approving and authorizing the execution of an annexation agreement
wherein the property owner agreed to annex the hereinafter described
territory to the City of Urbana in accordance with the terms of said
annexation agreement; and

WHEREAS, the territory to be annexed by this Ordinance is presently located within Champaign County's R-2 Single Family Residential district and R-5 Mobile Home Park district and upon annexation will be classified R-2 Single Family Residence upon annexation in accordance with the above-referenced annexation agreement; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the following described real estate, ViZ:

A tract of land being a part of the Northeast Quarter of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, being more particularly described as follows:

Beginning at the Northeast corner of said Section 4, proceed North 89°28'23" West 165.45 feet on a local bearing along the North line of the Northeast Quarter of said Section 4, to the East line of the West half of the East half of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of said Section 4 being the True Point of Beginning, thence continue North 89°28'23" West 521.85 feet along the North line of the Northeast Quarter to a point being 25.50 feet West of the Northwest corner of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of said Section 4; thence South 28°22'43" West 406.00 feet; thence South 00°44'47" West 1292.16 feet; thence South 89°26'22" East 875.60 feet to the East line of the Northeast Quarter of said Section 4; thence North 00°44'47" East 994.95 feet; along the said East line to a point being 9.95 chains South of the Northeast corner of Section 4; thence North 89°26'22" West 165.33 feet to the East line of the West Half of the East Half of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of said Section 4; thence North 00°44'10" East along the said East line 656.60 feet to the True Point of Beginning, encompassing 29.925 acres more or less in Champaign County, Illinois

commonly known for reference as 1909 E. Airport Road, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. The above-described parcels, prior to annexation, have the parcel index number 30-21-04-226-003 and a part of parcel index number 30-21-04-201-020, and following annexation the said parcels should bear the parcel index number 91-21-04-226-003. The above legal description being the same parcels of land which are subject to the annexation agreement between the parties referred to above.

Section 2. That the City Clerk be authorized and directed to record a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Recorder's Office of Champaign County, Illinois.

Section 3. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the County Clerk and County Election Authority of Champaign County, Illinois.

Section 4. The Zoning Ordinance of the City of Urbana, Illinois, and the Zoning Map of Urbana, Illinois, are hereby amended to classify the real property herein annexed as classified R-2 Single Family Residence upon annexation and in accordance with an annexation agreement approved and authorized on October 4, 1999 by Council Ordinance No. 1999-09-0981.

Section 5. The territory annexed herein is assigned to City of Urbana Ward 5.

Section 6. This Ordinance shall take effect at 12:00 p.m. CDT, April 13, 2000.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City

of Urbana, Illinois, at a regular meeting of said Council on the 3rd day of April , 2000 , A.D.
