

ORDINANCE NO. 2000-05-045

**AN ORDINANCE AMENDING SECTION 1-18 OF THE URBANA CITY CODE  
(MINIMUM FINE SCHEDULE FOR CERTAIN VIOLATIONS)**

WHEREAS, the system providing for the voluntary settlement of charges for violations of certain sections of the Urbana City Code was established pursuant to Ordinance No. 9394-17 which was enacted by the Urbana City Council on August 16, 1993; and

WHEREAS, the minimum finds established in that ordinance have not been amended since that date; and

WHEREAS, it has been determined by the Urbana City Council that the fines set forth in the schedule, because of inflation, have diminished their effectiveness as a deterrent,

NOW THEREFORE, BE IT ORDAINED THAT Section 1-18 is hereby amended to read in accordance with the attached.

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.


