AN ORDINANCE AMENDING THE ZONING MAP OF THE CITY OF URBANA, ILLINOIS

(For parcels located at 208 North Goodwin; 1101, 1102, 1102½, 1104, 1107, 1109, 1111 and 1113 West Main; 1101, 1103 and 1105 West Clark; and 205 North Harvey - Plan Case 1749-M-00)

WHEREAS, after due publication, a public hearing was held by the Urbana Plan Commission on July 13, 2000 concerning the petition filed by the petitioner in Plan Case No. 1749-M-00; and

WHEREAS, the requested rezoning is consistent with the City of Urbana's Official Comprehensive Plan Map, as amended in Plan Case No. 1749-CP-00, and with the goals and objectives of the City of Urbana Comprehensive Plan, as amended; and

WHEREAS, the Urbana Plan Commission voted 6 ayes and 0 nays to forward the case to the Urbana City Council with a recommendation to approve the rezoning request of the properties herein described below and commonly known as 1101, 1102, 1102½, 1104, 1107, 1109, 1111 and 1113 West Main, 208 North Goodwin, and 205 North Harvey from B-1, Neighborhood Business to B-3U, General Business - University and to rezone properties at 1101, 1103, and 1105 West Clark from R-5, Medium High Density Multiple Family Residential to B-3U, General Business - University; and

WHEREAS, the findings of the Plan Commission indicate that approval of the rezoning request would promote the general health, safety, morals, and general welfare of the public.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. The Zoning Ordinance and Zoning Map of the City of Urbana, Illinois, are herewith and hereby amended to change the zoning classification

of the following described areas commonly known as 1101, 1102, 1102 ½, 1104, 1107, 1109, 1111, and 1113 West Main, 208 North Goodwin, and 205 North Harvey from B-1, Neighborhood Business to B-3U, General Business - University and to rezone properties at 1101, 1103, and 1105 West Clark from R-5, Medium High Density Multiple Family Residential to B-3U, General Business - University.
