#### ORDINANCE NO. 2000-07-086

AN ORDINANCE CHAMPAIGN COUNTY CLERK ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANA

(James Gallivan Land Trust #1223 / A permanent non-exclusive easement for right-of-way purposes)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Eastern Prairie Fire Protection District, and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on <u>July 26</u>, 2000, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, <u>August 7</u>, 2000, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the <u>4th</u> day of <u>August</u>, 2000; and

Section 4. The Zoning Ordinance of the City of Urbana, Illinois, and the Zoning Map of Urbana, Illinois, are hereby amended to classify the real property herein annexed as IN Industrial upon annexation and in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance.

<u>Section 5</u>. The territory annexed herein is assigned to City of Urbana Ward 5.

Section 6. This Ordinance shall take effect at 12:00 p.m. CDT, August 8, 2000.
