

**AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93
OF THE URBANA LOCAL TRAFFIC CODE
REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION**

(Harvey Street at Fairview Avenue; Gregory Street at Fairview Avenue; Eagle Ridge Road at Mumford Drive; Eagle Ridge Court at Mumford Drive; Morrow Court at Mumford Drive; Ikenberry Court at Mumford Drive; Falcon Court at Mumford Drive; Meadowlark Court at Mumford Drive)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following intersection where drivers of vehicles shall be required to stop before entering the intersection:

Harvey Street	Northbound	Fairview Drive
Harvey Street	Southbound	Fairview Drive
Gregory Street	Southbound	Fairview Drive
Eagle Ridge Road	Northbound	Mumford Drive
Eagle Ridge Court	Southbound	Mumford Drive
Morrow Court	Southbound	Mumford Drive
Ikenberry Court	Northbound	Mumford Drive
Falcon Court	Southbound	Mumford Drive
Meadowlark Court	Northbound	Mumford Drive

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a regular meeting of said Council.
