# AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY CHARGE

CHAMPAIGN COUNTY CLERK

(Lee Commercial Site / 2401 N. Cunningham Avenue)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on July 26, 2001, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, August 6, 2001, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the 31st day of July, 2001; and

WHEREAS, the territory to be annexed by this Ordinance is presently located within Champaign County's B-4 General Business zoning district and upon annexation will automatically be classified B-3 General Business upon annexation in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance; and

WHEREAS, there are no electors residing within such territory; and

WHEREAS, it has been determined that said petition complies with all requirements of the law therefore; and

WHEREAS, the majority of the Members of the Council are of the opinion that it would be for the best interests of the people of the City of Urbana, Illinois, that said territory be annexed to and made a part of the said City.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS:

Section 1. That the following described real estate, viz:

A part of the Southeast Quarter of the Northwest Quarter of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, situated in Champaign County, Illinois, described as follows:

Beginning at the Northwest Corner of the South Half of the Southeast Quarter of the Northwest Quarter of Section 4, Township 19 North, Range 9 East of the Third Principal Meridian, and running thence North 403.8 feet to a stake, thence East 578.18 feet to the West line of U.S. Route 45, thence Southwest along the said West line of said right-of-way 448.28 feet to the North line of the South Half of the Southeast Quarter of the Northwest Quarter of said Section 4, thence West 338.50 feet along said North line to the place of beginning, in Champaign County, Illinois.

Containing 4.57 acres, more or less, all situated in Champaign County, Illinois

commonly known for reference as 2401 N. Cunningham Avenue, Urbana, Illinois, be and the same is hereby annexed to the City of Urbana, Illinois. Section 3. That the City Clerk be authorized and directed to file, for record, a certified copy of this Ordinance together with an accurate map of the territory hereinabove described in the Office of the County Clerk and County Election Authority of Champaign County, Illinois.

Section 4. The Zoning Ordinance of the City of Urbana, Illinois, and the Zoning Map of Urbana, Illinois, are hereby amended to classify the real property as B-3 General Business upon annexation in accordance with Article IV, Section IV-5 of the Urbana Zoning Ordinance.

Section 5. The territory annexed herein is assigned to City of Urbana Ward 5.


