AN ORDINANCE RELEASING AN EASEMENT IN THE LINCOLN CENTRE SUBDIVISION

WHEREAS, the plat of Lincoln Centre, dated October 12, 1978 and recorded February 6, 1979 as Document Number 79R2270 in Plat Book Z at Page 70 in the Office of the Recorder of Deeds of Champaign County, Illinois, depicted a certain easement ten feet (10') in width running along the west side of Lot 4 thereof, for the entire north/south dimension of said Lot 4; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That the easement shown on a plat dated October 12, 1978 and recorded February 6, 1979 as Document Number 79R2270 in Plat Book Z at Page 70 in the Office of the Recorder of Deeds of Champaign County, Illinois, described as the westerly ten feet (10') of even and equal width of Lot 4 except the northerly fifteen feet (15') and the southerly ten feet (10') thereof, is hereby released, vacated and extinguished upon a certified copy of this Ordinance being recorded with the Recorder of Deeds, Champaign County, Illinois.

Section 2. The plat attached hereto is incorporated in this Ordinance by reference.

Section 3. The City Clerk is hereby directed to record a certified copy of this Ordinance in the Office of the Recorder of Deeds, Champaign County, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a three-fourths (3/4) vote of the members of the City Council of the City of Urbana, Illinois, at a special meeting of said City Council.
