AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY CHAMPAIGN COUNTY CLERK (Freedom Oil Co. / 1812 N. Cunningham Avenue)

WHEREAS, the hereinafter described territory is situated in unincorporated territory adjacent to and contiguous to the City of Urbana, Illinois, and is part of the Carroll Fire Protection District, and includes certain territory within the Urbana Township, and Notice was given to the Trustees of said Fire Protection District, the Board of Township Trustees, and the Township Commissioner of Highways, said notices being mailed on January 22 , 2002, that this Ordinance would be voted upon at the regular meeting of this Council at 7:30 p.m., Monday, <u>February 4</u>, 2002, and the Affidavit of mailing such Notices was duly recorded with the Recorder of Deeds of Champaign County, Illinois, on the <u>22nd</u> day of <u>January</u>, 2002; and

Section 5. The territory annexed herein is assigned to City of Urbana Ward 5.


