

**AN ORDINANCE AUTHORIZING THE MAYOR TO ESTABLISH A PARKING METER ZONE ON
CERTAIN STREETS
(Goodwin Avenue)**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That pursuant to Section 23-231, entitled "Authority to Establish Parking Meters Zones," of Article XVII, entitled "Parking Meters," of the Urbana Local Traffic Ordinance, as amended, the Mayor be and the same is hereby authorized and directed to establish a parking meter zone upon the following portion of such street:

| <u>Street</u> | <u>From</u> | <u>To</u> | <u>Side of Street</u> |
|----------------|--|-----------|-----------------------|
| Goodwin Avenue | 357 feet south of the centerline of Springfield Avenue. | 462 feet | East Side |

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.




