AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF URBANAOUNTY CLERK

(801 E. Kerr / Involuntary)

WHEREAS, on Monday, April 3, 2006, the Urbana City Council directed the City Clerk to publish Notice that the annexation of the property therein described was being contemplated and would be considered by the Urbana City Council at its regular meeting on May 1, 2006; and
