AN ORDINANCE RE-APPROVING A FINAL SUBDIVISION PLAT

(Savannah Green Subdivision, Phase 6 - Plan Case No. 1904-S-04)

Subdivision Phase 6 attached hereto is hereby reapproved for two years from the date of this Ordinance.
