

**AN ORDINANCE AMENDING SCHEDULE L OF SECTION 23-187  
OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING  
PARKING AT ALL TIMES ON CERTAIN STREETS**

**(Rainbow View at Montgomery Street; Rainbow View at  
Ogelthorpe Avenue; Rainbow View at Abercorn Street)**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule L of Section 23-187, entitled "Parking Prohibited At All Times In Specified Places" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>From</u>	<u>To</u>	<u>Side of Street</u>
Rainbow View	100 ft. east of the centerline of Montgomery St.	100 ft. west of the centerline of Montgomery St.	South
Rainbow View	100 feet east of the centerline of Ogelthorpe Ave.	100 feet west of the centerline of Ogelthorpe Ave.	South
Rainbow View	The center line of Abercorn St.	100 feet west of the centerline of Abercorn St.	South

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the

effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
