

ORDINANCE NO. 2009-09-108

**AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183
OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING
PARKING AT ALL TIMES ON CERTAIN STREETS**

(Smith Road, Ogelthorpe Avenue, Montgomery Street, Abercorn Street)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

| <u>Street</u> | <u>Between</u> | <u>Side of Street</u> |

| Smith Road | From 626 feet north of the centerline of Florida Avenue to 706 feet north of the centerline of Florida Avenue | East Side |
| Ogelthorpe Avenue | From 660 feet north of the centerline of Florida Avenue to 740 feet north of the centerline of Florida Avenue | East Side |
| Ogelthorpe Avenue | From 78 feet north of the centerline of Michigan Avenue to 158 feet north of the centerline of Michigan Avenue | East Side |
| Montgomery Street | From 660 feet north of the centerline of Florida Avenue to 740 feet north of the centerline of Florida Avenue | East Side |

Abercorn Street

From 660 feet north of East Side
the centerline of Florida
Avenue to 740 feet north of
the centerline of Florida
Avenue

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

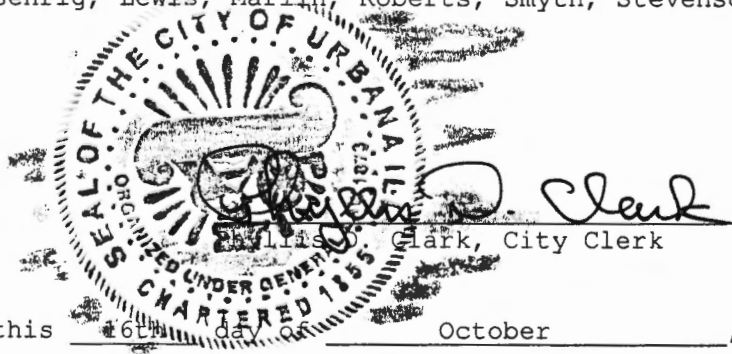
