

ORDINANCE NO. 2010-11-107

**AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183
OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING
PARKING AT ALL TIMES ON CERTAIN STREETS**

(Montclair Road, Springfield Avenue, Rainbow View)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle at any time:

<u>Street</u>	<u>Between</u>	<u>Side of Street</u>
Montclair Road	From the centerline of Vine Street to 108 feet west of the centerline of Vine Street	Both Sides
Springfield Avenue	From 280 feet west of the centerline of McCullough Street to 485 feet west of the centerline of McCullough Street	North Side
Rainbow View	From the centerline of Smith Road to the centerline of Ogelthorpe Avenue	South Side

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability

incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
