## ORDINANCE NO. 2012-11-103

## AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-183 OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING AT ALL TIMES ON CERTAIN STREETS

## (Florida Avenue)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-183, entitled "Parking Prohibited At All Times on Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portions of streets where no person shall park a vehicle at any time:

Florida Avenue	From the centerline of Vine Street to 520 feet east of the centerline of Linden Drive	North Side
Florida Avenue	From 160 feet west of the centerline of Philo Road to 155 feet east of centerline of Philo Road	North Side
Florida Avenue	From 147 feet west of the centerline of Adams Street to 88 feet east of the centerline of Lincolnwood Drive	North Side
Florida Avenue	From 88 feet west of the centerline of Curtiss Drive to 114 feet east of the centerline of Curtiss Drive	North Side
Florida Avenue	From 124 feet west of the centerline of Rutledge Drive to the centerline of Bermuda Drive	North Side

Florida Avenue From the centerline of South Side

Vine Street to 275 feet east of the centerline of

Vine Street

Florida Avenue From 105 feet west of South Side

the centerline of

Anderson Street to 105 feet east of the centerline of

Anderson Street

Florida Avenue From 105 feet west of South Side

the centerline of Cottage Grove Avenue to 165 feet east of the centerline of Cottage Grove Avenue

Florida Avenue From 532 feet west of South Side

the centerline of Philo Road to 285 feet east of the centerline of

Philo Road

Florida Avenue From 70 feet west of South Side

the centerline of James Cherry Drive to the centerline of Kinch

Street

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance

shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.
