ORDINANCE NO. 2014-09-087

AN ORDINANCE AMENDING SCHEDULE J OF SECTION 23-172 OF THE URBANA LOCAL TRAFFIC CODE REMOVING CURB LOADING ZONES ON CERTAIN STREETS

(Harvey Street)

WHEREAS, the City of Urbana ("Urbana") is an Illinois Municipal

Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of

the State of Illinois;

WHEREAS, the City of Urbana has adopted a local traffic code which is set forth in its ordinances as Section 23.1 et seq.; and

WHEREAS, the City of Urbana, pursuant to the aforesaid traffic code, has the authority to regulate locations marked as curb loading zones on its streets and in its parking lots; and

WHEREAS, the City of Urbana regulates loading zones on streets to provide public safety and access;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule J of Section 23-172, entitled "Standing in Curb Loading Zones" of Article XIII of the Urbana Local Traffic Code, is hereby amended by DELETING from that schedule the following portion of a street established as a loading zone:

Harvey Street from 495 feet north of the centerline of Fairview Avenue to 530 feet north o the centerline of Fairview Avenue		Everyday	24	10 minutes

Section 2. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.
