ORDINANCE NO. 2016-12-117

AN ORDINANCE AMENDING SCHEDULE H OF SECTION 23-93 OF THE URBANA LOCAL TRAFFIC CODE REQUIRING STOP SIGNS AT A CERTAIN INTERSECTION

(Main Street at Smith Road; Tatman Court at Industrial Circle)

WHEREAS, the City of Urbana (hereinafter, the "City"), an Illinois municipal corporation (the "City") and a home rule unit of local government pursuant to Article 7, § 6 of the Constitution of the State of Illinois and 65 ILCS 5/1-1-10; and

WHEREAS, the City has adopted and has the authority to amend or modify its local traffic code which is set forth in the Urbana City Code as Section 23.1 et seq.; and

WHEREAS, the City, pursuant to the aforesaid traffic code, has the authority to designate and describe through streets and maintain stop signs at any such intersection on street that intersection such through streets;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows:

Section 1. That Schedule H of Section 23-93, entitled "Stop Signs

Pursuant to Section 23-93", of Article VIII of the Urbana Local Traffic Code,

is hereby amended by ADDING to that schedule the following intersection where

drivers of vehicles shall be required to stop before entering the intersection:

Street	Direction	Street	
Main Street	Eastbound	Smith Road	
Main Street	Westbound	Smith Road	
Tatman Court	Eastbound	Industrial Circle	

<u>Section 2</u>. All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>Section 3</u>. This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

Section 4. The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a special meeting of said Council.
