

**ORDINANCE NO. 2018-05-039**

**AN ORDINANCE AMENDING SCHEDULE K OF SECTION 23-184  
OF THE URBANA LOCAL TRAFFIC CODE PROHIBITING PARKING  
DURING CERTAIN HOURS ON CERTAIN STREETS**

**(Vawter Street)**

**WHEREAS**, the City of Urbana (“Urbana”) is an Illinois Municipal Corporation pursuant to the Illinois Constitution of 1970 and the Statutes of the State of Illinois;

**WHEREAS**, the City of Urbana has adopted a local traffic code which is set forth in its ordinances as Section 23.1 *et seq.*; and

**WHEREAS**, the City of Urbana, pursuant to the aforesaid traffic code, has the authority to regulate parking on its streets and in its parking lots; and

**WHEREAS**, the City of Urbana restricts parking on streets to provide public safety and access;

**NOW THEREFORE, BE IT ORDAINED** by the City Council of the City of Urbana, Illinois, as follows:

**Section 1.** That Schedule K of Section 23-184, entitled "Parking Prohibited During Certain Hours On Certain Streets" of Article XIV of the Urbana Local Traffic Code, is hereby amended by ADDING to that schedule the following portion of a street where no person shall park a vehicle on the designated days or times:

Vawter Street from 67 feet south of the centerline of Brighton Drive to 122 feet south of the centerline of Brighton Drive	East	Monday through Friday	7:00 AM to 4:00 PM

**Section 2.** All ordinances, resolutions, motions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

**Section 3.** This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights acquired, or a liability incurred, or any cause or causes of action

acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.




