

**ORDINANCE NO. 2018-07-050**

**AN ORDINANCE AMENDING URBANA CITY CODE CHAPTER 14,  
SECTION 14-7, REGARDING THE SCHEDULE OF FEES**

**(Small Cell Wireless Provider Fees)**

**WHEREAS**, the City Council did on the 18th day of June 2018, pursuant to Ordinance No. 2018-05-034, adopt a Schedule of Fees for the various licenses, permits, fines, and other fees required under the Urbana City Code; and

**WHEREAS**, the City Council finds that the best interests of the City are served by making a limited amendment to that Schedule of Fees, pursuant to Urbana City Code Section 14-7 (b), to establish license fees for small cell wireless providers.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Urbana, Champaign County, Illinois, as follows:

**Section 1.**

Urbana City Code Chapter 14, "Licenses and Permits," Section 14-7, "Schedule of fees," Subsection (B), "General Licenses and Permits," Part 8, "Public Works Permits/Licenses," is hereby amended by adding a new Subpart (g) "Small Cell Wireless Provider Application Fees," which new Subpart shall read as follows:

(g) Small Cell Wireless Provider Fees:

1. Single facility collocations on existing poles or wireless support structures .....\$ 650
2. Multiple facility collocations on existing poles or wireless support structures .....\$ 350
3. Single facility collocations on new poles or wireless support structures .....\$1,000
4. Small wireless facility annual recurring application fee (per facility).....\$ 200

**Section 2.**

Those sections, paragraphs, and provisions of the Urbana City Code that are not expressly amended or repealed by this Ordinance are hereby re-enacted, and it is expressly declared to be the intention of this Ordinance not to repeal or amend any portions of the Urbana City Code other than those expressly set forth as amended or repealed in this Ordinance. The invalidity of any section or provision of this Ordinance hereby passed and approved shall not invalidate other sections or provisions thereof.

**Section 3.**

This Ordinance shall not be construed to affect any suit or proceeding pending in any court, or any rights

acquired, or a liability incurred, or any cause or causes of action acquired or existing prior to the effective date of this Ordinance; nor shall any right or remedy of any character be lost, impaired, or affected by this Ordinance.

**Section 4.**

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.






