## ORDINANCE NO. <u>2020-09-048</u>

## AN ORDINANCE REPEALING ORDINANCE NO. 8687-97 AND APPROVING A SPECIAL USE PERMIT

## (1911 E. Main St. / Plan Case 2403-SU-20)

WHEREAS, the City of Urbana ("City") is a home rule unit of local government pursuant to Article VII, Section 6, of the Illinois Constitution, 1970, and may exercise any power and perform any function pertaining to its government and affairs, and the passage of this Ordinance constitutes an exercise of the City's home rule powers and functions as granted in the Illinois Constitution, 1970; and

WHEREAS, on June 15, 1987, the City Council passed Ordinance No. 8687-97, granting a special use permit for the Champaign County Humane Society and Champaign County Board to operate an animal shelter at 1911 East Main Street in the R-4, Medium Density Multiple-Family Residential, Zoning District; and

WHEREAS, the Champaign County Humane Society and Champaign County Board have petitioned the City for approval of another special use permit to allow construction of a new training building, expansion of the existing building, and operation of an animal shelter in both buildings at 1911 East Main Street; and

WHEREAS, the Urbana Zoning Ordinance allows the City Council to authorize a special use permit in any zoning district for the construction, expansion, or alteration of any structure or use by a public service entity for a charitable or philanthropic use; and

WHEREAS, the special use permit would continue to allow for the Humane Society's current general mission "to provide animal care, shelter and adoption and act as a resource center offering programs and education for the general public" and the expanded mission of providing an annex "for education programs, pet-related services, staff activities, and storage;" and

WHEREAS, the special use permit would replace the special use permit issued in 1987 under Ordinance No. 8687-97 and would apply only to the three-acre tract leased by the Humane Society at 1911 East Main Street and not to the remainder of the 51.24-acre parcel owned by Champaign County; and WHEREAS, the proposed use would continue to be conducive to the public convenience due to its well-known presence at this location since 1988 and its convenient proximity to the Champaign County Animal Services Facility; and

WHEREAS, the proposed expansion of the animal shelter will not be injurious or detrimental to the R-4 Zoning District or the general public, as the shelter has operated at the same location since 1988, and its programming will remain similar in scope, magnitude, and timing; and

WHEREAS, the proposed development is consistent with the development regulations for, and preserves the essential character of, the R-4, Medium Density Multiple-Family Residential, Zoning District; and

WHEREAS, after due publication, the Urbana Plan Commission held a public hearing on September 10, 2020, and voted with six (6) ayes, one (1) recusal, and zero (0) nays to forward Plan Case 2403-SU-20 to the Urbana City Council with a recommendation to approve the request for a special use permit, subject to the conditions specified in Section 2 herein; and

WHEREAS, approval of the special use permit, with the condition set forth below, is consistent with the requirements of Section VII.7.A. of the Urbana Zoning Ordinance, Special Use Procedures, Public Building Exemption Procedures, and with the general intent of that section of the Ordinance; and

WHEREAS, the City Council, after due consideration, finds that repealing Ordinance No. 8687-97 and approving a special use permit as herein provided are in the best interests of the residents of the City and are desirable for the welfare of the City's government and affairs.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Urbana, Illinois, as follows:

#### Section 1.

Ordinance No. 8687-97 is hereby repealed upon the effective date of this Ordinance. The repeal of such Ordinance shall not abrogate or affect any act committed or done or any penalty or forfeiture incurred or any pending litigation or prosecution under such repealed Ordinance.

#### Section 2.

In place of said Ordinance herein repealed, a new Ordinance is hereby enacted and a special use permit is hereby approved to allow construction of a new building, expansion of an existing building, and operation of an animal shelter at 1911 East Main Street, Urbana, Illinois, in the R-4, Medium Density Multiple-Family Residential, Zoning District, with the following condition: Construction must be in general conformance with the attached site plan entitled "Site Layout Plan – Champaign County Humane Society – 1911 E. Main St." dated June 1, 2020 (Attachment 1).

## Legal Description:

Commencing at the intersection of the South Right-of-Way line of East Main Street in the City of Urbana, Illinois, with the East line of Section 16, Township 19 North, Range 9 East of the 3rd Principal Meridian; thence South a distance of 583' along the East line of said Sec. 16 to the point of beginning; thence West a distance of 470' along a parallel of the East Main Street South Right-of-Way line; thence South a distance of 278.04' parallel with the East line of said Sec. 16; thence East a distance of 470' along a parallel of said Sec. 16; thence East a distance of 470' along a parallel of the East line of said Sec. 16; thence East a distance of 470' along a parallel of the East line of said Sec. 16; thence East a distance of 470' along a parallel of the East Main Street South Right-of-Way line to a point in the line of the East line of said Sec. 16 to the point of beginning, at the comer of a tract described in Book 648, Page 40 of the Champaign County Recorder's Office.

Upon approval of this Ordinance, the City Clerk is directed to record a certified copy of this Ordinance with the Champaign County Office of Recorder of Deeds.

The City Clerk is directed to publish this Ordinance in pamphlet form by authority of the corporate authorities, and this Ordinance shall be in full force and effect from and after its passage and publication in accordance with Section 1-2-4 of the Illinois Municipal Code.

This Ordinance is hereby passed by the affirmative vote, the "ayes" and "nays" being called, of a majority of the members of the Council of the City of Urbana, Illinois, at a meeting of said Council.




