

RESOLUTION IN REFERENCE TO VACATION  
OF PORTIONS OF SEVERAL STREETS AND ALLEYS  
IN DOWNTOWN URBANA AND IN REGARD TO ADDITIONAL  
OFF STREET PARKING FOR THE CITY OF URBANA  
AND RELATED MATTERS

---

WHEREAS, a plan exists to provide additional business district within a certain area of the downtown central business district and for further renewal and redevelopment of the downtown central business district area within certain boundaries as provided by such plan, in the City of Urbana, a municipal corporation, and,

WHEREAS, an engineering, economic and development plan is in existence and there is a necessity to vacate certain portions of several streets and alleys in and near the downtown central business district, and,

WHEREAS, pursuant to such plans for redevelopment of the downtown central business district, additional municipal off-street parking facilities appear to be needed in and near such redevelopment, and,

WHEREAS, in such a redevelopment program certain municipal parking areas may need to be altered and additional revenue bonds will become necessary to provide and construct additional municipal off-street parking areas in and near such areas, in the City of Urbana, Illinois, and,

WHEREAS, certain amendments may be necessary to the Zoning Ordinance of the City of Urbana to implement such a plan and redevelopment, and,

WHEREAS, numerous procedures and work will be needed to implement such a plan and redevelopment and for accomplishments which are incidental to the program and which will be needed in connection with the redevelopment, and related matters, and,

WHEREAS, in order to properly accomplish the intentions of the plans for redevelopment, the City of Urbana necessarily needs to delegate certain powers to the off-street parking commission, certain city officials, engineers, attorneys, and committees toward the aims of the program;

THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF URBANA,  
ILLINOIS:

That the City Council of Urbana, Illinois, on behalf of the City of Urbana, Illinois, a municipal corporation, declares that this resolution and the provisions and proposed accomplishments are toward the best interests of the City of Urbana and the citizens, residents and people of the City; and the City Council further declares the intention to accomplish the aims and construction of the plans for such redevelopment of the downtown central business district, and,

BE IT FURTHER RESOLVED by the City Council of the City of Urbana, Illinois, that the off-street parking commission of the City of Urbana, Illinois, is hereby authorized to proceed toward such redevelopment and toward a revenue bond issue for additional off-street parking in and near the downtown central business district, in the City of Urbana, Illinois, and to proceed and to take actions to provide money and construction for the accomplishment of the redevelopment; and the City Council of the City of Urbana, Illinois, further hereby resolves that the off-street parking commission is hereby authorized to engage engineers and attorneys toward the issuance of revenue bonds for additional off-street parking facilities in and near such areas in the City of Urbana, Illinois, and to facilitate the actual maintenance and operation of such additional off-street parking areas and to vacate or to extend, widen and resurface streets and alleys, toward the redevelopment, and for traffic and parking purposes;

BE IT FURTHER RESOLVED that the Plan Commission and City Council take such action as may be necessary to amend the Zoning Ordinances of the City of Urbana and administer zoning pursuant to such ordinances, to facilitate the implementation of the above plan and redevelopment;

The City Council of the City of Urbana, Illinois, hereby further resolves that the agents and attorneys authorized by this resolution shall have authority and function in accordance with the delegations of authority pursuant to this resolution; and the City Officials, Engineers and Attorneys are hereby authorized and directed to act in accordance with the intended delegated authority provided in this Resolution.


