

RESOLUTION TO RAZE OR REMOVE IMPROVEMENTS ON CITY PROPERTY

WHEREAS, the City of Urbana, is the owner of the herein described real estate acquired for public parking of motor vehicles, and,

WHEREAS, upon each of said tracts, there is a building which will need to be removed or razed in order to carry out such public parking plan.


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, that the City Attorney cause a legal publication to be published in a newspaper published in the City of Urbana, asking for bids separately for removal of each of three said buildings, or for bids separately to raze the said buildings, which notice shall be given at least seven days before bids are to be received, said bids to be filed with the Clerk of the City of Urbana.

The Parking Commission is hereby authorized to award a contract for the best bid or bids, most favorable to the City of Urbana, Illinois; the successful bidder or bidders shall file evidence of having workman's compensation insurance and public liability insurance satisfactory to the Mayor, and save the City harmless in connection herewith; the successful bidder or bidders to be entitled to the respective buildings, and their contents, including all materials therein, as owned by the City of Urbana, the successful bidder or bidders are to obtain a building permit or such permits, and to remove the structures within four weeks after the contract is awarded, cleaning up all debris, the successful bidder not being required to remove any concrete floors on the ground level or below ground level, said bids to be sealed bids and to be filed by the day and hour as set forth in the notice, with the Mayor of said City.

Said real estate is as follows:

Lot 1 except the east 22 feet thereof, and Lot 2 in James T. Roe's Second Addition to the City of Urbana, Illinois;  
And the real estate formerly owned by the Illinois Crop Improvement Association, Inc., and Dr. W. L. Veirs, both in Lot 8 of Central Business Addition, Urbana, Illinois;  
All situated in the City of Urbana, Champaign County, and the State of Illinois.


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS,
