RESOLUTION FOR IMPROVEMENT BY MUNICIPALITY UNDER THE ILLINOIS HIGHWAY CODE

BE IT RESOLVED, by the Council of the City of Urbana, Illinois

that the following described street(s) be improved under the Illinois Highway Code:

BE IT FURTHER RESOLVED,

1. That the proposed improvement consist of concrete base-course widening, bituminous concrete surfacing and resurfacing, concrete curb and gutter, concrete driveway pavement, concrete sidewalks, street lighting, street drainage and other necessary incidental construction, all in accordance with plans, specifications and special provisions to be prepared by the City and approved by the Dept. of Public Works and Buildings, Division of Highways, 138 feet wide and shall be designated as Section 138 C.S.

2. That there is hereby appropriated the sum of \$1000.00 for the improvement of said section from the municipality's allotment of Motor Fuel Tax funds.

3. That said work shall be done by Contract (Specify Contract or Day Labor) and
