

R E S O L U T I O N

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, A MUNICIPAL CORPORATION, IN CHAMPAIGN COUNTY, AND STATE OF ILLINOIS, that the corporate authorities of the municipality is of the opinion that a tax levy is needed for Cunningham Township, in Champaign County and the State of Illinois, and for said City, for street and bridge purposes, for the year commencing May 1, 1968, and ending April 30, 1969, to exceed .06% of the valuation of the property of said township, and such opinion is the opinion of more than three-fourths of the members elected to the City Council of the City of Urbana, Illinois, a municipal corporation, and such a greater levy for street and bridge purposes is needed to the extent of an additional levy of a sum not to exceed .04% of such taxable property, as equalized or assessed by the Department of Revenue of the State of Illinois; and, such levy and additional levy for street and bridge purposes in said township for such fiscal year is in addition to any other tax that the municipality is authorized to levy for such purposes, and is in addition to any tax that such a municipality is now authorized to levy upon all property within the municipality, and such tax and additional tax is in addition to the amount authorized to levy for general ^{corporate} purposes in said township, in said City, for street and bridge purposes; and, said City, a municipal corporation, includes wholly within its corporate limits said Cunningham Township.

FURTHER, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, a municipal corporation, in Champaign County and the State of Illinois, that in the opinion of more than three-fourths of the members elected to the City Council of the City of Urbana, Illinois, a municipal corporation, a levy for street and bridge purposes is needed in excess of .06% of such taxable property as equalized or assessed by the Department of Revenue of the State of Illinois, and not to exceed .1% of such taxable property, for such street and bridge purposes in the municipality.
