



RESOLUTION

WHEREAS, the City of Urbana has entered into an agreement with the State of Illinois for the improvement of Illinois Route 130 (F.A.S. Route 524) known as State Section 200(W,RS), City Section 151-CS; and

WHEREAS, in compliance with the aforementioned agreement, it is necessary for the City to appropriate Motor Fuel Tax Funds to pay its share of the cost of said improvement,

NOW, THEREFORE, BE IT RESOLVED, that there is hereby appropriated the sum of nine hundred-fifty DOLLARS (\$950.00), or so much thereof as may be necessary, from any money now or hereafter allotted to the City under the provisions of the Motor Fuel Tax Law, to pay its share of the cost of this improvement as provided in the agreement; and,

BE IT FURTHER RESOLVED, that upon completion of the improvement, the City will pay to the Department of Public Works and Buildings of the State of Illinois in a lump sum from any funds allotted to the City under the Motor Fuel Tax Law an amount equal to its obligation incurred under this agreement, and,

BE IT FURTHER RESOLVED, that the City agrees to pass a supplemental resolution to provide necessary funds for its share of the cost of this improvement if the amount appropriated herein proves to be insufficient to cover said cost.

AGREEMENT

This agreement, entered into this day of A.D. 1971, by and between the STATE OF ILLINOIS, acting by and through its DEPARTMENT OF PUBLIC WORKS AND BUILDINGS, hereinafter called the STATE, and the City of Urbana, of the State of Illinois, hereinafter called the CITY.

WITNESSETH:

WHEREAS, the STATE, in order to facilitate the free flow of traffic and insure safety to the motoring public, is desirous of improving Illinois Route 130 in Urbana (F.A.S. Route 524, State Section 200 (W,RS), City Section 151-CS) from the intersection of Illinois Route 130 and Cottage Grove Avenue to the south City limits by widening and resurfacing and existing 20' pavement to 24' (providing for two-12' traffic lanes), patching the existing pavement and by performing all other work necessary to complete the improvement in accordance with the Letter of Understanding signed by the City on June 16, 1970, a copy of which is attached hereto as "Exhibit A", with the following exceptions:

NOW, THEREFORE, in consideration of the mutual convenants contained herein, the parties hereto agree as follows:

- 1. The STATE agrees to resurface the parking lane on the east side from Cole Place to Fairlawn Drive with a thickness varying from the featheredge at the edge of the traffic lane to two (2) inches at the face of curb.
- 2. The STATE agrees to pay all construction and engineering costs, subject to reimbursement by the CITY as hereafter stipulated.
- 3. The STATE agrees to pay the construction and engineering costs for the resurfacing of the parking lane at the driveway entrances from the edge of the traffic lane to the face of curb plus a 3 foot featheredge behind the face of curb in the entrances.
- 4. The CITY agrees to reimburse the STATE \$950.00 to pay construction and construction engineering costs for resurfacing the parking lane outside of the limits of the driveway entrances.

5. The CITY has passed a resolution appropriating sufficient Motor Fuel Tax Funds to pay its share of the cost of this improvement, a copy of which is attached hereto as "Exhibit B".

- 6. Upon completion of this improvement, the CITY agrees to maintain or cause to be maintained, the parking lane, manholes, catch basins, storm sewers used for the drainage of this improvement, curbs adjacent to the parking lane, and municipal utilities and appurtenances.
- 7. This agreement shall be binding upon and inure to the benefit of the parties hereto, their successors and assigns.
