

RESOLUTION RELATING TO CARROLL SUBDIVISION AREA LOCAL IMPROVEMENT NO. 4, URBANA & CHAMPAIGN SANITARY DISTRICT

WHEREAS, the Urbana & Champaign Sanitary District, by its Board of Local Improvements, has adopted a scheme to provide sanitary sewer service in the Carroll Subdivision Area which includes territory situated within the City of Urbana, described on the attached Exhibit A; and

WHEREAS, the territory described in the attached Exhibit A was included within the Urbana & Champaign Sanitary District prior to its annexation to the City of Urbana; and

WHEREAS, the Trustees of the Urbana & Champaign Sanitary District have requested the Mayor and Council of the City of Urbana to consent to and acquiesce in the taking of jurisdiction of property described in Exhibit A for the purpose of installation of a lateral sewer system.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Mayor and Council of the City of Urbana that the Urbana & Champaign Sanitary District and its Board of Local Improvements may take jurisdiction over the territory lying within the City of Urbana described on the attached Exhibit A for the purpose of installation of a lateral sewer system and the condemnation of property for easements for the construction of said system and the issuance of local improvement bonds to pay the cost thereof, provided, however, the consent and acquiescence herein granted is conditioned upon the said Urbana & Champaign Sanitary District agreeing to the following matters:

- a) The said District shall restore all streets broken into for this project to the same condition as such streets were immediately prior to being so disturbed;
- b) The said District shall, during the course of construction, maintain adequate ingress and egress for the residents of the area;
- c) The said District shall obtain adequate permanent maintenance easements for all new sewer lines installed pursuant to the above-described local improvement project.

BE IT FURTHER RESOLVED that the City Clerk of the City of Urbana

shall notify the Clerk of the Board of Trustees of the Urbana & Champaign Sanitary District when this resolution has been adopted and transmit to the Clerk of said Board of Trustees a certified copy hereof.

Board of Local Improvements

Tracts of land within the corporate boundaries of the City of Urbana and within the boundary of area probably benefited by the improvements of Local Improvement No.4, by the Urbana & Champaign Sanitary District.

Tract I

A tract of land lying in the northwest quarter of Section 9 Township 19 North, Range 9 East of the Third Principal Meridian, said Tract being bounded as follows:

Beginning at a point on the North right-of-way line of Kerr Avenue, said point being the intersection with the West line of the East half of Lot 10 of a subdivision of the West half of the northwest quarter of Section 9, being a subdivision of the Estate of W.T. Webber by R.T. Webber, Administrator; thence West along said North right-of-way line to the West line of Lot 11 of said Subdivision; thence North along said West line to the North line of the South two-thirds of Lot 11; thence East along the last described North line to the West line of the East half of Lot 10 of said Subdivision; thence South along the last described West line to the point of beginning.

Situated in Champaign County, Illinois.

Tract II

A tract of land lying in the northwest quarter of Section 9, Township 19 North, Range 9 East of the Third Principal Meridian, said Tract being bounded as follows:

Beginning at the southeast corner of Lot 3 of a subdivision of the West half of the northwest quarter of Section 9, being a subdivision of the Estate of W.T. Webber by R.T. Webber, Administrator; thence West along the South line of Lot 3 to a point 224.45 feet East of the easterly line of U.S. Route 45 right-of-way; thence North 163.55 feet; thence West 164.10 feet to the easterly line of U.S. Route 45 right-of-way; thence northeasterly along the easterly right-of-way line of Route 45 to the South right-of-way line of Perkins Road; thence East along said South right-of-way line to the East line of Lot 3; thence South along the last described East line to the point of beginning.

Situated in Champaign County, Illinois.
