# AGREEMENT CONCERNING USE OF URBANA SANITARY LANDFILL BY VILLAGE OF PHILO

of March, A.D. 1976, by and between the Village of Philo, a municipal corporation, organized and existing under the laws of the State of Illinois, and located in Champaign County, Illinois, hereinafter referred to as "Village" and the City of Urbana, a municipal corporation, organized and existing under the laws of the State of Illinois, hereinafter referred to as "City".

### WITNESSETH:

WHEREAS, the Village of Philo does not provide any facilities for the disposal of solid waste collected from places within said Village, but desires to provide for the disposal thereof at the Urbana Sanitary Landfill and pay to the City of Urbana an annual payment, together with a use fee for each cubic yard of material so deposited, for the disposal of such solid waste materials.

#### NOW, THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. Provided Village makes the payments as specified in Paragraph 2 herein, City agrees that all solid waste material, which is hauled to the Urbana Sanitary Landfill from places within the Village of Philo by Sanitary Haulers licensed by the City during this or any subsequent year to which this agreement may be extended, may be deposited at said landfill. City further agrees that Village may haul and deposit its own refuse at said landfill at no additional cost to that as herein established in Paragraph 2.
- 2. The Village agrees that for and in consideration of depositing rights provided in Paragraph 1 above, Village will pay to the City an annual sum of Two thousand one hundred dollars (\$2,100.00) prior to July 1, 1976 and prior to July 1 of each succeeding year

This agreement shall be in full force and effect for one (1) year from the date of commencement of services hereunder provided and automatically renewed and extended from year to year during each succeeding year provided, however, that this agreement may be modified or terminated by either party by giving sixty (60) days notice to the other party of its election to do so.
