RESOLUTION

WHEREAS, Article VII Section 10, (Intergovernmental Cooperation) of the 1970

Illinois Constitution encourages intergovernmental cooperation among units

of local government, and

WHEREAS, intergovernmental cooperation has been increasing among units of local government serving the greater Champaign-Urbana area, as evidenced by the following:

Mutual aid for fire protection among the Twin Cities of Champaign and Urbana and the University of Illinois;

Mutual aid among the several police departments, including the Sheriff's department;

A joint CATV franchise for the Twin Cities, including services to the University;

A Twin Cities Solid Waste Disposal agreement;

Joint study of a number of ordinances that have been proposed for both Champaign and Urbana;

An administrative committee from the Twin Cities and the University;

A multi-agency approach for the control of St. Louis encephalitis bearing mosquitoes;

Enforcement ordinances passed by each of the Twin Cities for the Champaign-Urbana Public Health District;

Cooperation between each City and its Park District, including such items as exchange of services and construction of new facilities;

Cooperation among Park Districts and School Districts, including joint planning of school-park complexes;

Cooperation between the Twin Cities and the Urbana and Champaign Sanitary District in carrying out engineering studies;

Numerous other areas of cooperation, and

- WHEREAS, other types of increased intergovernmental cooperation, such as joint purchasing, joint training, joint investment of reserves, equipment exchanges and personnel pooling offer the possibility of improvement of services provided by units of local government, and
- WHEREAS, a number of areas in the United States have also increased intergovernmental cooperation through the device of adopting areawide plans for the provision of government services, which in some instances has been achieved through the consolidation of units of government, and
- WHEREAS, a careful study of methods to further increase cooperation among the units serving the greater Champaign-Urbana area should result in improving the processes of local government, and
- WHEREAS, a Study Commission composed of 23 citizens, including neither officials serving on governing boards of the units or agencies of government herein listed nor administrative staff of such units or agencies, could provide broad community representation to investigate the possibilities of improved service through intergovernmental cooperation, including consideration of consolidation of units of government, and
- WHEREAS, such a Commission could make appropriate recommendations to increase intergovernmental cooperation, including an implementation schedule,
- NOW, THEREFORE, BE IT RESOLVED jointly by the City Councils of the City of Champaign, Illinois, and the City of Urbana, Illinois, that
 - A Study Commission on Intergovernmental Cooperation be created to study intergovernmental cooperation among local units of government serving the greater Champaign-Urbana area, including the possibility of consolidation of units of government;
 - 2. Said Study Commission shall have 23 members, appointed as follows:
 - a) one member appointed by the governing board of each of the following:

Champaign Unit 4 Schools
Urbana School District #116
Champaign Park District
Urbana Park District
City of Champaign Township
Cunningham Township
County of Champaign
Urbana-Champaign Sanitary District
Champaign-Urbana Public Health District
Champaign-Urbana Mass Transit District

- b) One member appointed by the Chancellor of the Urbana-Champaign campus of the University of Illinois
- c) One member appointed by the President of Parkland Junior College
- d) Five members appointed by the Mayor of Champaign, with the advice and consent of the City Council of Champaign
- e) Five members appointed by the Mayor of Urbana, with the advice and consent of the City Council of Urbana
- f) One member appointed jointly by the Mayors of Champaign and Urbana, said person to be Chairperson of said Commission
- 3. Members of the Study Commission shall be neither officials serving on governing boards of the units or agencies of government herein listed nor central administrative staff of such units or agencies.
- 4. The appointments to be made by the Mayors shall be made following the appointments by the other units of government, except that the Chairperson shall be appointed prior to any other appointments.
- 5. Should any units of government herein named decline within forty-five days from date of adoption of this resolution to join in the appointment of persons to said Commission, the Mayors shall have the right to jointly appoint additional persons to ensure that an odd number of persons serve on the Commission, with the total number of Commissioners not to exceed 23.
- 6. In order to provide adequate staff for said Commission, each City

 Council will allocate \$5,000 for funding said Commission. Other units

 of local government are encouraged to allocate funds for the Commission.

 Further, the Commission is encouraged to seek funds from the Department

 of Local Government Affairs of the State of Illinois and other public and

 private (e.g. foundation) sources.

A RESOLUTION

A JOINT RESOLUTION OF THE CITY OF CHAMPAIGN AND THE CITY OF URBANA CREATING A STUDY COMMISSION ON INTERGOVERNMENTAL COOPERATION

WHEREAS, a Study Commission composed of 23 citizens, including neither officials serving on governing boards of the units or agencies of government herein listed nor administrative staff of such units or agencies, could provide broad community representation to investigate the possibilities of improved service through intergovernmental cooperation, including consideration of consolidation of units of government; and

WHEREAS, such a Commission could make appropriate recommendations to increase intergovernmental cooperation, including an implementation schedule,

NOW, THEREFORE, BE IT RESOLVED JOINTLY BY THE CITY COUNCILS OF THE CITY OF CHAMPAIGN, ILLINOIS AND THE CITY OF URBANA, ILLINOIS, that:

- 1. A Study Commission on Intergovernmental Cooperation be created to study intergovernmental cooperation among local units of government serving the greater Champaign-Urbana area, including the possibility of consolidation of units of government;
- 2. Said Study Commission shall have twenty-three (23) members, appointed as follows:
 - a. One (1) member appointed by the governing board of each of the following:Champaign Unit 4 Schools

Urbana School District #116
Champaign Park District
Urbana Park District
City of Champaign Township
Cunningham Township
County of Champaign
Urbana-Champaign Sanitary District
Champaign-Urbana Public Health District
Champaign-Urbana Mass Transit District

- b. One (1) member appointed by the Chancellor of the Urbana-Champaign campus of the University of Illinois
- c. One (1) member appointed by the President of Parkland Junior College
- d. Five (5) members appointed by the Mayor of Champaign, with the advice and consent of the City Council of Champaign
- e. Five (5) members appointed by the Mayor of Urbana, with the advice and consent of the City Council of Urbana
- f. One (1) member appointed jointly by the Mayors of Champaign and Urbana, said person to be Chairperson of said Commission
- 3. Members of the Study Commission shall be neither officials serving on the governing boards of the units or agencies of government herein listed nor central administrative staff of such units or agencies.

- 4. The appointments to be made by the Mayors shall be made following the appointments by the other units of government, except that the Chairperson shall be appointed prior to any other appointments
- 5. Should any units of government herein named decline within forty-five (45) days from date of adoption of this Resolution to join in the appointment of persons to said Commission, the Mayors shall have the right to jointly appoint additional persons to ensure that an odd number of persons serve on the Commission, with the total number of Commissioners not to exceed twenty-three (23).
- 6. In order to provide adequate staff for said Commission, each City Council will allocate \$5,000 for funding said Commission. Other units of local government are encouraged to allocate funds for the Commission. Further, the Commission is encouraged to seek funds from the Department of Local Government Affairs of the State of Illinois and other public and private (e.g. foundation) sources.
- 7. Said Commission shall from time to time issue interim reports, with the first interim report issued no later than one (1) year from the date of adoption of this Resolution.
- 8. Said commission shall issue its final report, including an implementation schedule, no later than two (2) years from the date of adoption of this Resolution.
