



ILLINOIS:


That the Mayor of the City of Urbana, Illinois,





SUBJECT:

Enclosed is a proposed agreement with the County of Champaign to assist the County in providing parking for jurors. This agreement has been worked out initially between me and members of a County Board committee and subsequently between the County people and Nelson Licht. In view of the fact that spaces are not all occupied 100% of the time, this seems to be a reasonable agreement. In addition, Stan Summers of the County Board will arrange to have an estimate made of the actual number of hours used by the jurors during brief periods covered by the agreement. I am asking the Committee to consider this Thursday night, and I have already used my executive authority to proceed at this time to assist the County.

CONTRACT FOR PARKING SPACES

THIS AGREEMENT made this 21 day of June, 1976, by and between the County of Champaign, Illinois, a body politic and corporate, hereinafter referred to as the COUNTY, and the City of Urbana, Illinois, a body politic and corporate, hereinafter referred to as the CITY.

WITNESSETH THAT:

WHEREAS, the COUNTY has the need for additional parking spaces when petit juries are in session; and

WHEREAS, the COUNTY desires to meet that need; and

WHEREAS, the COUNTY desires to obtain additional parking spaces during the times aforesaid and the CITY is able and willing to furnish said spaces; and

WHEREAS, the COUNTY and the CITY have reached an agreement pursuant to the authority granted by the Illinois Constitution of 1970, Article 7, Section 10, whereby this objective may be accomplished.

NOW, THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, it is agreed by and between the COUNTY and the CITY as follows:

1. The CITY shall provide 60 parking spaces on the Lincoln Square Parking Lot contiguous to Elm and Vine Streets, and/or on the Civic Center Parking Lot in Urbana, during the periods of June 14-18; 21-25; June 28-July 2, and July 12-16, 1976, all dates inclusive.
2. The COUNTY will use identification badges to identify jurors' cars covered by this agreement.
3. The CITY shall refrain from enforcing parking meter restrictions with respect to said 60 vehicles during the hours of 9:00 A.M. to 5:00 P.M., on the dates aforesaid, and shall void any and all tickets written on said vehicles after 5:00 P.M. on said dates upon receipt of notice from the Circuit Clerk that the vehicle ticketed was parked pursuant to this agreement and the juror was still on duty.

4. The COUNTY shall pay to the CITY \$435.00 for said spaces for the time as aforesaid.

5. This agreement shall become effective when signed by the duly authorized officers, duly attested and sealed on the day and date first above written.

IN WITNESS WHEREOF, the parties hereto, pursuant to authority granted by their respective governing bodies, have caused these presents to be executed by their duly authorized officers, duly attested and their corporate or official seals, if any they have, to be hereunto affixed on the day and date first above written.
