WHEREAS, these Ordinances further provide that such appointments are subject to the approval of the City Council.

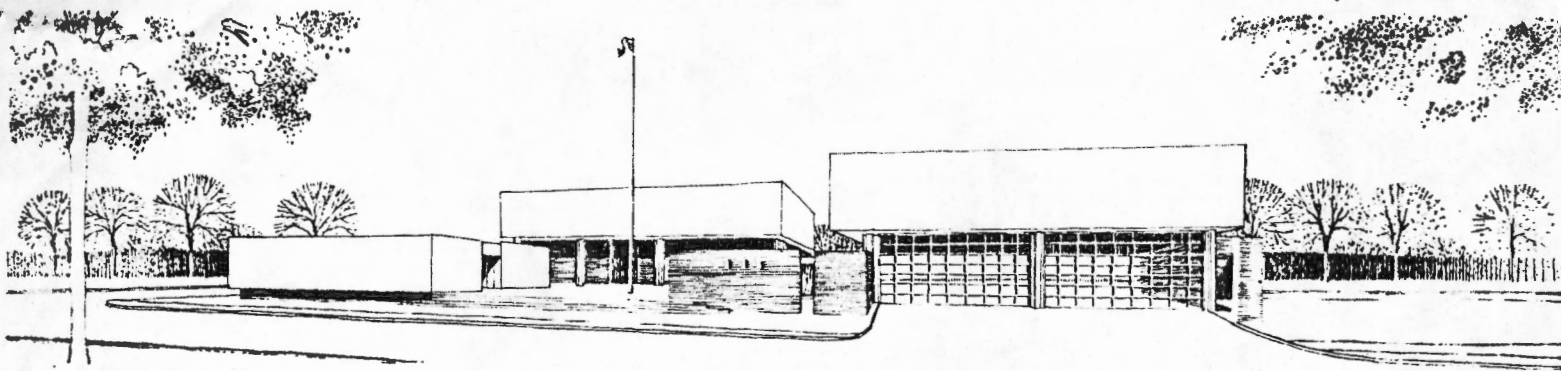
NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF URBANA, ILLINOIS:
