RESOLUTION NO. 7677-R16 A RESOLUTION DECLARING RESULTS OF SPECIAL ELECTION ON QUESTION OF INCREASING THE ANNUAL LIBRARY TAX FOR MAINTENANCE AND OPERATION WHEREAS, on the 11th day of September, 1976, there was held in and for the City of Urbana, Champaign County, Illinois, a special election to submit to the voters of the City of Urbana the question of whether the annual library tax for maintenance and operation should be increased from .2364% to .35% of the value of all taxable property in the City, and WHEREAS, the said special election has been regularly called and held as provided by law, and the returns of said election, including the tally sheets, poll records, certificates of results, and other returns of said election have been filed with the City Clerk of the City of Urbana and the returns are now before the City Council of the City of Urbana and the said Council is familiar therewith; NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF URBANA, ILLINOIS, as follows: Section 1. That the special election held on the 11th day of September, 1976, was held in all respects as provided by law. Notice of said election was given by publishing the notice once, on August 19, 1976, in the Champaign-Urbana Courier and once, on August 20, 1976, in the Champaign-Urbana News-Gazette, the same being newspapers published in and having a general circulation within the City of Urbana, and which dates were not less than 20 days in advance of the date of said special election. The judges appointed by this City Council were duly qualified to fill such offices in each of the precincts, and were duly sworn to perform their duties before the commencement of said election. The returns of said special election have been duly canvassed by said judges and were filed with the City Clerk of the City of Urbana. Section 2. That the City Council finds from a canvass of the returns of said special election that the following votes were cast in each of the three (3) designated precincts on the question, "shall the annual library tax for maintenance and operation in the City of Urbana, - 1 -

Champaign County, Illinois be increased from .2364% to .35% of the value of all taxable property in the City?":
