
A RESOLUTION APPROVING AN AMENDMENT

ILLINOIS, as follows:



AN AGREEMENT AMENDING APPENDIX "B"  
OF THE AGREEMENT BETWEEN THE CITY OF  
URBANA, ILLINOIS AND AMERICAN FEDERATION  
OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES,  
AFL-CIO, COUNCIL 990, LOCAL 1331,  
DATED THE 5TH DAY OF DECEMBER, 1975

WHEREAS, Article XVI, Section 16.1, entitled, "Re-opening", of the Agreement entered into the 5th day of December, 1975, between the City of Urbana, Illinois (hereinafter referred to as the "City") and the American Federation of State, County, and Municipal Employees, AFL-CIO, Council 990, Local 1331 (hereinafter referred to as the "Union"), makes provision whereby the Union may notify the City in writing of its desire to reopen the Agreement; provided such reopener shall be limited to salaries and insurance benefits received by employees covered by the Agreement for the year July 1, 1976 through and including June 30, 1977; and

WHEREAS, the Union duly notified the City in writing of its desire to so reopen the Agreement on April 15, 1976, a date within the period specified in Article XVI, Section 16.1, of the Agreement to do so; and

WHEREAS, upon such notice being given, the duly authorized representatives of both the City and the Union met for the purpose of negotiating in good faith the salaries and insurance benefits for the year July 1, 1976 through and including June 30, 1977.

NOW, therefore, in consideration of the mutual covenants and agreements herein contained, the City and the Union do mutually covenant and agree to amend Appendix "B" of the Agreement as follows:

Effective July 1, 1976, through and including December 30, 1976, the base salary for employees covered by this Agreement, determined herein as the annual base and represented in both annual and hourly rates (based upon 2,080 hours per year) shall be as follows:

The City and the Union both acknowledge that the foregoing amended schedules establishing the annual base salary as represented in both annual and hourly rates (based upon 2,080 hours per year) for the periods July 1, 1976 through and including December 30, 1976, and January 1, 1977 through and including June 30, 1977, constitute all of the amendments to the Agreement under Article XVI, Section 16.1 of the Agreement entitled, "Reopening" and that this amendment, together with the Agreement, shall govern the salaries and insurance benefits received by the employees covered by this agreement for the year July 1, 1976 through and including June 30, 1977.
